Important information for using the 2023 taxonomies

At the time of this release, HMRC have not yet published which accounting periods the FRC 2023 and 2022 taxonomies are valid for. HMRC have informed us of the following:

- **2023 taxonomies:** The accounting period valid from date and to dates will be published on HMRC's website in due course.
- **2022 taxonomies:** The accounting period valid from date will be 1st April 2015 and the valid to date is expected to be 31st March 2024.

The dates will be confirmed by HMRC on their accepted taxonomies page in due course.
